# **Texas Legislative Update Summary of 88th Session**

On a mobile device, you can sign in your support for some very important House Bills being considered this week (Senate bills do not have this option). You can sign in your support until the hearing has adjourned. It's quick, easy, and most of all, it's critical that we speak up!

The bills, what they intend to do, and the links to sign are outlined below.

#### Bills For Monday, March 27, 2023:

#### <u>Protecting Children From Gender Re-assignment Treatments And Procedures:</u>

<u>House Bill 1686 (Support)</u> - Prohibits surgical and drug induced gender transitioning, gender reassignment, and gender dysphoria treatments/procedures on children under 18. (By Rep. Tom Oliverson)

The state Senate has already had their hearing on this issue with SB 14 by Sen. Donna Campbell, and it was passed out of committee. HB 1686 is the House companion bill.

<u>HB 888 (Support)</u> - Extending the statute of limitations on a health care liability claim involving certain gender modification drugs provided to and procedures performed on a minor. (By Rep. Slawson)

<u>HB 1952 (Support)</u> - Relating to the required inclusion of a person's sex on a birth certificate. (Rep. Steve Toth)

### Last Week on Thursday, March 23, 2023:

<u>SB12 (Support)</u> - Relating to restricting certain sexually oriented performances on public property, on the premises of a commercial enterprise, or in the presence of a child; authorizing a civil penalty; creating a criminal offense. (By Sen. Bryan Hughes)

<u>SB 1601 (Support)</u> - Relating to prohibiting municipal libraries that host certain events (such as drag shows/drag reading hour) from receiving state funding. (By Sen. Bryan Hughes)
