# <u>Legislative Alert – May 22, 2023</u>

This is the last week to act to either pass or stop important legislation that will affect you and your family. There have been some major victories—you are making a difference!

## **BILLS THAT PASSED | VICTORIES**

1. Protecting Texas Children from Being Exposed to Sexually Explicit Performances, SB 12. SB 12, known as the "drag queen bill," by Senator Bryan Hughes and Representative Matt Shaheen—protects children, 18 and under, from exposure to sexually oriented performances at a commercial enterprise, by holding those responsible civilly liable of a Class A misdemeanor offense. SB 12 allows a municipality to regulate sexually oriented performances to prevent sexually orientated performances from taking place on public property.

# 2. Ban on Child Gender Transition Procedures, SB 14.

SB 14, by Senator Donna Campbell and Representative Tom Oliverson, bans gender transitioning, gender reassignment, and gender dysphoria procedures, surgeries, and treatments on children, 18 and under. Texas is the 19th state to pass this ban protecting our children.

#### 3. Save Women's Sports Act, SB15

SB 15, known as the "Save Women's Sports Act", by Senator Mayes Middleton and Representative Valoree Swanson, protects female athletes in college from having to unfairly compete against biological males in women's sports competitions.

# **BILLS THAT STILL NEED ACTION**

#### 1. Religious Liberty for Attorneys, SB 559

SB 559, by Senator Bryan Hughes and Representative Briscoe Cain, prohibits the state bar from limiting the ability to obtain, maintain, or renew a law license based on the person's religious belief and burden a state bar applicant's free exercise of religion, freedom of speech about their faith, membership in any religious organization, or freedom of association. The bill will be brought to the House floor for a vote on May 23.

# 2. Parental Consent for a Student's Participation in Human Sexuality Instruction in Public Schools. SB 163

SB163, by Senator Donna Campbell and Representative Cole Hefner, seeks to remove the expiration date that requires school districts to obtain written consent from a student's parent before the student may be provided with human sexuality instruction. The requirement is set to expire on August 1, 2024. The bill will be brought to the House floor for a vote on May 23.
