### 2<sup>nd</sup> Special Session Alert:

## We Need Your Immediate Help to Protect the Unborn

We need your help **today** to pass the Woman and Child Protection Act (HB7) to stop abortion pill traffickers who are sending approximately 19,000 abortion pills into Texas through the mail each year.

Mailing these deadly pills or administering them in Texas for abortion is already illegal. The Woman and Child Protection Act would empower any Texan to sue traffickers, mailers, distributors, and manufacturers of abortion pills and allow Texans to shut down companies that sell abortion pills.

It's time to move this forward into law, but legislators are facing a lot of pressure to let the bill die. We cannot let this happen. Today, chemical abortions are the number one threat to unborn babies.
